- ❖ The Worthington Farmer's Market has always asked that the produce sold at our markets be grown within 60 miles of Worthington. Please sell only locally grown food items.
- ❖ No spot is reserved until payment and all required information is received. Please refer to the Vendor Handbook for a full list of required items.
- ❖ Everyone will be assigned a designated location at the Tuesday market for the year.
- ❖ Those assigned a spot not located under the permanent pavilion will be provided with a canopy tent with sidewalls.
- ❖ The annual vendor fee is \$25 per 8 x 10 square. There are 2 squares between posts under the pavilion, with a total of 4 squares across under the roof space. If you plan to expand as the season progresses, please plan accordingly. You will be asked to stay within your paid for space if you have not planned for the expansion.
- ❖ The space will include walkways, so full utilization of the area will not be possible
- ❖ An additional one-time electricity fee of \$25.

1. Acknowledgment of Market Rules:

I, the undersigned, have read, understand, and agree to comply with all rules, regulations, and guidelines set forth for the Worthington Farmer's Market. I understand that these rules are established to ensure the safety, fairness, and enjoyment of all participants and attendees.

2. Fee Submission:

I confirm that I have reviewed the fee structure associated with participating in the Worthington Farmer's Market and have accurately completed and submitted all applicable fees as required.

3. Compliance and Enforcement:

I understand and agree that compliance with the rules and regulations of the Worthington Farmer's Market is mandatory. I acknowledge that FORWARD Worthington, as the managing entity, will actively monitor compliance. Noncompliance may result in immediate removal from the market, forfeiture of fees, and potential exclusion from future participation at the discretion of FORWARD Worthington.

2026 Accounts Payable Schedule

FORWARD Worthington will issue checks to vendors weekly for the dollar amount of the previous week's tokens and Market Bucks redeemed. Please allow up to 7 days for your check to get to you by mail. Refer to your Token Collection Log weekly totals to ensure your reimbursement check total is accurate.

VENDOR AGREEMENT
